EUROMAR once again commissioned to operate the International Shipping Register of Madeira (MAR)

EUROMAR, the exclusive agency for the International Shipping Register of Madeira (MAR), warmly welcomes the renewal of the concession.

The MAR registry has undergone an impressive development, with more than 1,000 vessels registered under the Portuguese flag. SDM emphasizes the crucial role of EUROMAR and the long-standing partnership between SDM and EUROMAR in this success story.

The Regional Government of Madeira has recently announced that the concession granted to S.D.M. (Sociedade de Desenvolvimento da Madeira, SA (SDM)) will be officially renewed for another 5-year period. SDM is the responsible entity, on behalf of the Regional Government of Madeira for the management, administration and promotion of the International Business Centre of Madeira – of which the International Shipping Register of Madeira (MAR) is a part. EUROMAR acts on behalf of and by contract with the concessionaire SDM.

SDM is proud of the success story of MAR and its consistent growth and generation of revenue for Madeira within the European maritime landscape.

It is encouraging to see that even companies traditionally focused on offshore non-EU registers are now considering turning towards European flags.
